

TERM	DEFINITION
AL	Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
Level 1 Assessment	A Level 1 assessment is a study of the water system to identify potential problems and determine, if possible, why total coliform bacteria have been found in our water system.
Level 2 Assessment	A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine, if possible, why an E. coli MCL violation has occurred or why total coliform bacteria have been found in our water system, or both, on multiple occasions.
MCL	Maximum Contaminant Level: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
MCLG	Maximum Contaminant Level Goal: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
MFL	Million Fibers Per Liter
MRDL	Maximum Residual Disinfectant Level: The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
MRDLG	Maximum Residual Disinfectant Level Goal: The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
Mrem/Year	Millirems Per Year (A measure of radiation absorbed by the body)
NTU	Nephelometric Turbidity Units
pCi/l	Picocuries Per Liter (A measure of radioactivity)

Water System Information

The Cudahy Water Utility was established in 1947. It has a 6.0 million-gallon per day conventional water treatment plant that uses Lake Michigan as a water source.

The treatment plant uses a coagulation, flocculation, sedimentation, filtration, UV disinfection and chlorine disinfection to provide clean safe water to the City of Cudahy. Utility Governance

The Water Utility budget, capital planning and rates are overseen and approved by the Water Utility Water Commission. The Commission is made up of five members appointed to five year terms by the Mayor. Educational Information

The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally- occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.

Health Information

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's safe drinking water hotline (800-426-4791).

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune systems disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Additional Health Information - If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Cudahy Waterworks is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline or at www.epa.gov/safewater/lead.

Information on Monitoring for Cryptosporidium - During a 2-year period, we are required to collect data to determine whether our treatment is adequate to prevent cryptosporidium from entering your drinking water. Last year cryptosporidium was detected 1 time(s) in the untreated water. Cryptosporidium .1 OOCYTS / Liter on 10-19-2016

Cryptosporidium - is a microbial parasite naturally found in surface water throughout the world. If ingested, it can cause intense gastrointestinal distress in otherwise healthy people.

Turbidity Monitoring - In accordance with s. NR 810.29, Wisconsin Administrative Code, the treated surface water is monitored for turbidity to confirm that the filtered water is less than 0.1 NTU/0.3NTU. Turbidity is a measure of the cloudiness of water. We monitor for it because it is a good indicator of the effectiveness of our filtration system. During the year, the highest single entry point turbidity measurement was .15 NTU. The lowest monthly percentage of samples meeting the turbidity limits was 100 percent.

Lead Awareness and Drinking Water Safety - Lead is not found in Cudahy's source water or public water system. However, lead can enter water as the result of the wearing away of materials containing lead in building fixtures, internal plumbing, or in the service line that brings water to your home. When water stands for several hours or more in fixtures or pipes that contain lead, the lead may leach into the water. It is also possible that physical disturbance of the piping may release lead into the water. Since 1994, the Cudahy Water Utility has safely treated its water with ortho-phosphate to reduce the risk of lead leaching from plumbing materials into water. This compound forms a protective coating inside pipes and is considered to be the best practice for the control of lead in drinking water. However, some homes are more at risk for lead in drinking water due to characteristics of the plumbing at the individual residence.
