Cudahy Bus Stop Improvements
Milwaukee County Community Development Block Grant

OWNER/TIME: The City of Cudahy is soliciting bids for handicap accessible improvements to bus stop locations in the City. Sealed bids will be received by the City of Cudahy, Milwaukee County, Wisconsin, until **Friday, August 3, 2018 at 10:00 a.m.**, at the City of Cudahy, City Hall, 5050 So. Lake Drive, P. O. Box 100510, Cudahy, Wisconsin 53110. Bid proposals will be publicly opened and read aloud at the above time and place. Each bid proposal must be submitted on the bid/proposal form provided in the Contract Documents and shall be enclosed in a sealed envelope addressed to the City of Cudahy and marked "Bid" with the project name.

The project consists of the removal and replacement of curb and sidewalk at an intersection on Lake Drive in the City of Cudahy and the construction of handi-cap accessible ramps as part of the Milwaukee County Community Grant program. The work needs to be completed by November 22, 2018. An estimate of quantities is:

SPECIAL NOTICE TO CONTRACTORS: This project is funded by the U.S. Department of Housing and Urban Development through the Milwaukee County Community Development Program. Firms bidding on this project are advised the awarded firm shall be required to:

- (1) Implement federal labor standards provisions and pay employees wages and fringe benefits at levels that meet or exceed a federal or state wage decision (included in bid documents);
- (2) Submit weekly payroll forms to Milwaukee County with each invoice or payment request.
- (3) Use Minority Business Enterprises for at least 20%, and Women Business Enterprises for at least 5%, of the total contract amount, this may be satisfied through subcontracts and/or the purchase of services or supplies; and
- (4) Comply with all regulations and procedures established by the U.S. Department of Housing and Urban Development and Milwaukee County for this project, and ensure all subcontractors also comply.
- (5) Document compliance with Equal Employment Opportunity requirements; and
- (6) Provide a Dunn and Bradstreet Number for prime and all sub-contractors or suppliers and evidence that the firm is not on the Federal list of debarred contractors.

Contract Documents may be obtained from the City of Cudahy Engineering Office, City Hall, (5050 So. Lake Dr.) or digitally through the City "Drop-Box" by calling (414) 769-2212 starting **Monday, July 20, 2018** between the hours of 7:30 a.m. to 4:30 p.m., Monday through Friday. The Contract Documents are available for free. All bidders shall bid in accordance with, and shall bid upon the forms provided.

STATUTORY PROVISIONS: The contract letting shall be subject to the provisions of the Wisconsin Statutes, including Section 62.15, 66.0901, 66.0903, 779.14 through 779.16. Minimum wage scales to be paid on the project shall be in accordance with the prevailing wage rates per the U.S Department of Housing & Urban Development Davis-Bacon Labor Standards.

BID GUARANTEE: No bid will be received unless a certified check or bank draft payable to the City of Cudahy, or a satisfactory bid bond in an amount no less than five percent (5%) of the bid, shall accompany each bid as a guarantee that if the bid is accepted, the bidder will execute and file the Agreement and a 100% performance bond and payment bond, within ten (10) days after the Notice of Award. In case the bidder fails to file such contract and bond within the time set forth, the check or bid bond shall be forfeited to the City of Cudahy as liquidated damages.

BID WITHDRAWAL: No bid shall be withdrawn for a period of ninety (90) days after the bid opening date without the consent of the City of Cudahy.

BID REJECTION: The City of Cudahy reserves the right to accept any bid most advantageous to the City, waive any technicality or reject any or all bids.
