OWNER/TIME: The City of Cudahy is soliciting bids for the milling and asphalt resurfacing of various streets within Cudahy. Sealed bids will be received by the City of Cudahy, Milwaukee County, Wisconsin, until **Friday, March 22, 2019 @ 10:30 a.m.**, at the City of Cudahy, City Hall, 5050 So. Lake Drive, Cudahy, Wisconsin 53110. Bid proposals will be publicly opened and read aloud at the above time and place. Each bid proposal must be submitted on the bid/proposal form provided in the Contract Documents and shall be enclosed in a sealed envelope addressed to the City of Cudahy and marked "Bid" with the project name.

The project consists of milling the entire roadway and the placement of asphalt pavement on various streets within the City of Cudahy. Project can be schedule between June 1 and Oct 1, 2019. Project includes all labor, equipment, materials and all work necessary in connection with the asphalt paving improvements: (All quantities are approximate)

The Contract Documents are available for free. All bidders shall bid in accordance with, and shall bid upon the forms provided.

STATUTORY PROVISIONS: The contract letting shall be subject to the provisions of the Wisconsin Statutes, including Section 62.15, 66.09, 779.14 and 779.16.

BID GUARANTEE: No bid will be received unless a certified check or bank draft payable to the City of Cudahy, or a satisfactory bid bond in an amount no less than five percent (5%) of the bid, shall accompany each bid as a guarantee that if the bid is accepted, the bidder will execute and file the Agreement and a 100% performance bond and payment bond, within ten (10) days after the Notice of Award. In case the bidder fails to file such contract and bond within the time set forth, the check or bid bond shall be forfeited to the City of Cudahy as liquidated damages.

BID WITHDRAWAL: No bid shall be withdrawn for a period of ninety (90) days after the bid opening date without the consent of the City of Cudahy.

BID REJECTION: The City of Cudahy reserves the right to accept any bid most advantageous to the City, waive any technicality or reject any or all bids. Bidder will be required to submit prequalification prior to the award date. Review and acceptance of prequalification will be made by the City as part of the award.
