Discussion and necessary action regarding request for Special Event Permit of Laura Martin (St. Francis South Shore Christmas Parade) to facilitate a joint St. Francis/Cudahy Christmas Parade on December 1, 2018 at 4:00 P.M. **MOTION BY JUSTIN MORALEZ, SECOND BY GREG WITKOWSKI** to approve request to hold parade along the new route (Grange lineup to Packard and north on Packard to Library Drive with the understanding that the event sponsors will be responsible for all costs incurred by the City. Motion carried unanimously.

Discussion and necessary action regarding "A Charter Ordinance Creating Section 2-29 of the City of Cudahy Municipal Code to Create Four-Year Staggered Alderperson Terms". **MOTION BY ROBERT HAINES, SECOND BY RICHARD HASKE** to approve ordinance to stagger aldermanic terms with amendment to create 3-year staggered alderperson terms with the selection method for which districts will get the shortened terms to be decided by a draw from a hat, and to submit question to the County as a binding referendum for the November election. Motion carried unanimously.
5. Discussion and necessary action regarding "A Charter Ordinance Creating Section 2-29 of the City of Cudahy Municipal Code to Create Four Year Staggered Alderperson Terms and Establish Term Limits". **MOTION BY ALD. MORALEZ, SECOND BY ROBERT HAINES** to deny. Motion carried unanimously.
