**ORDINANCE NO. 2317.3**

**AN ORDINANCE AMENDING SUBSECTION 1.47(1) OF THE CITY  
OF CUDAHY MUNICIPAL CODE CONCERNING THE LOCATION  
OF POLLING PLACE IN THE FOURTH AND FIFTH  
ALDERMANIC DISTRICTS TO BECOME EFFECTIVE ON THE  
AUGUST 9, 2016 PARTISAN PRIMARY ELECTION**

**WHEREAS**, the Common Council of the City of Cudahy changed various polling places in 2009 to accurately reflect the locations of the City polling places, and

**WHEREAS**, Ward 10 of the Fourth Aldermanic District currently shares a polling place at Jones School with Wards 13 & 14 of the 5<sup>th</sup> Aldermanic District and Ward 15 of the Fifth Aldermanic District currently shares a polling place at Mitchell School with Wards 11 & 12 of the 4<sup>th</sup> Aldermanic District, and

**WHEREAS**, in an effort to achieve county-wide uniformity in voting procedures, Milwaukee County mandated a change to voting equipment and funded five machines for the City of Cudahy, and

**WHEREAS**, administering an election utilizing one machine at combined polling places is not an optimum election procedure and does not achieve election administration efficiency as it pertains to manpower, simplicity, transparency and cost.

**NOW, THEREFORE**, the Common Council of the City of Cudahy, Wisconsin, does hereby ordain the following:

**Section 1.** Subsection 1.47(1) of City of Cudahy Municipal Code is hereby amended to read as follows:

- 1) **FOURTH ALDERMANIC DISTRICT** Wards 10, 11 and 12 at General Mitchell Elementary School located at 5950 S. Illinois Avenue.
- 2) **FIFTH ALDERMANIC DISTRICT** Wards 13, 14 and 15 at J.E. Jones Elementary School located at 5845 S. Swift Avenue.

**Section 2.** All ordinances or parts of ordinance contravening the provisions of this ordinance are hereby repealed.

**Section 3.** If any part or parts of this ordinance are invalid, it shall not invalidate the entire ordinance.

**Section 4.** This Ordinance shall take effect upon passage and publication as provided by law, and the City Clerk shall so amend the Code of Ordinances of the City of Cudahy, and shall indicate the date and number of this amending ordinance therein.
