ORDINANCE NO. 2284.3

AN ORDINANCE TO AMEND SEC. 11.06(3)(ee) OF THE CUDAHY CODE OF ORDINANCES PROHIBITING OWNERSHIP OF DUCKS WITHIN CITY LIMITS

WHEREAS, the City of Cudahy provides for the keeping and regulation of fowl and other animals within its borders, and

WHEREAS, keeping and maintaining wild animals in a city environment does not provide a suitable environment for the owners of those pets, the owner's neighbors, or the wild animals, which are best left in their natural environment, and

WHEREAS, appropriate care for wild animals requires considerable expertise, specialized facilities, and lifelong dedication to the animals, and

WHEREAS, the Center for Disease Control discourages the keeping of wild animals due to the real possibility of human contagion, and

WHEREAS, the Humane Society of the United States, the nation's largest animal protection organization, officially opposes keeping wild animals as pets, whether native and nonnative species, and whether the animal was caught in the wild or bred in captivity.

NOW, THEREFORE, the Common Council of the City of Cudahy in consideration of the aforementioned issues, in order to protect the public welfare of both people and animals, does hereby ordain the following:

Section 1. Section 11.06(5)(ee) is amended as follows:

- (ee) Except in properly zoned districts, horses, mules, ponies, donkeys, cows, pigs, goats, sheep, chickens, ducks, or any animal raised for fur-bearing purposes, unless otherwise permitted elsewhere in this Code.

Section 2. All ordinances or parts of ordinance contravening the provisions of this ordinance are hereby repealed.

Section 3. If any part or parts of this ordinance are invalid, it shall not invalidate the entire ordinance.

Section 4. This Ordinance shall take effect upon passage and publication as provided by law, and the City Clerk shall so amend the Code of Ordinances of the City of Cudahy, and shall indicate the date and number of this amending ordinance therein.
